Nomination form for the election of Committee Members

1. The management of the Sailing Division is vested in the Sailing Division Committee. The Sailing Division Committee is elected at the Annual General Meeting by way of a vote by those Members eligible to vote. There are five permanent Sailing Division Committee positions: Captain, Vice-Captain, Secretary, Treasurer and Chief Safety Regulations Officer.

The Sailing Division Committee may, from time to time, include additional positions that the Sailing Division Committee deems to be to the benefit of the Sailing Division.

2. The Sailing Division has two classes of Membership each subject to an annual subscription additional to the RMYC-PH membership subscription:
 - 2.1. **Sailing Members** who must also be a financial Boat Owner, General, Veteran or Life members of RMYC-PH. Sailing Members shall have voting rights at any Annual General Meeting, Special General Meeting or Skippers Meeting of the Sailing Division. They have full access to the marina.
 - 2.2. **Crew Members** who must also be Crew Members of RMYC-PH. Crew Members shall have no voting rights at any meeting of the Sailing Division. They have access to the marina on race days.

3. **Sailing Division Committee - Eligibility Requirements:**

Throughout this document, membership classes are as defined in the RMYC-PH Constitution.

3.1 The positions of Sailing Captain and Sailing Vice Captain must be filled by Sailing Members who are registered Sailing Boat Owners and should have served at least one year on the Sailing Division Committee.

3.2 Other positions on the Sailing Division Committee must be filled by Sailing Members with at least 50% being Registered Sailing Boat Owners.

3.3 If insufficient Nominations are received for the Sailing Division Committee positions, subject to the requirements of 3.1 and 3.2 above, members may be Proposed and Seconded for the vacant positions at the AGM or any adjournment thereof.

4. **Nominations for Sailing Division Committee positions and any other business on which the meeting is required to vote must be lodged with the Secretary of the RMYC-PH Sailing Division in writing with a Proposer and Secunder on or before 13th August 2018.**
5. Only financial Sailing Members of the Sailing Division (over 18 years of age) are eligible to propose, second and vote at an Annual General Meeting.
